 - a. *Must email Emily and opt out by September 30, 2016*
 - i. *MUST be in writing to her by September 30, 2016*
 - b. *October 1, 2016 you can no longer opt out.*
 - i. *You will be in until July 20, 2017.*
4. Are Paras that have been medical trained required to go on trips and take care of the general ed students?

 - b. *Why are teachers not being required to do the medical training?*
